The Eastern and Western parts of the Roman Empire had distinct traditions, languages, and practices, contributing to estrangement and misunderstanding between the two regions (Meyendorff, 1989).

Differences in church polity and governance among denominations, such as episcopal, Presbyterian, and congregational systems, impact decision-making processes, leadership structures, and the interpretation of doctrine. These differences can lead to divergent practices in worship, discipline, and administration J. Witte Jr. (1993:28, 328-351), A. Buzzard & C. Hunting (1998), and P. Navas (2011).

5.6 Eschatology

Beliefs about the end times, the second coming of Christ, and the final judgment vary among Christian denominations, with variations in interpretations of biblical prophecies, the nature of the millennium, and the timing of eschatological events can lead to theological disagreements and different emphases in preaching and teaching C. J. Bleeker (1963: 250-272). Some focus on ethical living and the transformation of society in anticipation of the Kingdom of God. Grudem (1994).

5.7 Trinitarian Doctrine

The doctrine of the Trinity, which teaches the belief in one God existing in three persons - Father, Son, and Holy Spirit, is a central tenet of Christian faith. While most Christian denominations adhere to this doctrine, interpretations and emphasis on different aspects of

the Trinity may vary, leading to theological differences A. Buzzard & C. Hunting, (1998).

5.8 Salvation, Atonement and Justification

Christian traditions hold diverse views on the nature of salvation, the role of faith in salvation, and the understanding of Christ's atoning work on the cross. The knowledge of how individuals are saved and justified before God varies among Christian denominations. Some emphasize faith alone (*sola fide*), while others stress the importance of works or sacraments in salvation. Others stress the combination of faith and good works. These differences can impact beliefs about grace, repentance, and the role of human effort in salvation D. A. Carson (1997).

5.9 Sacraments and Ordinances

The understanding and practice of sacraments and ordinances, such as baptism and the Eucharist (Lord's Supper), vary among Christian traditions. The number and nature of sacraments recognized by different Christian traditions vary. For example, Catholicism recognizes seven sacraments, while many Protestant denominations recognize fewer. The significance and efficacy attributed to each sacrament can also differ, influencing worship practices and beliefs about the means of grace. J. D. Small (2003); G. Martinez (2003). Some denominations emphasize the sacramental nature of these rituals, while others view them as symbolic acts of faith J. F. White (2010)

5.10 Authority of Scripture and Tradition

Christian denominations differ in their views on the authority of Scripture and tradition in matters of faith and practice. While all Christians regard the Bible as sacred, interpretations of its teachings and the role of tradition alongside or above scripture can vary, affecting theological beliefs and ethical practices C. E. Braaten (2001) and P. Jasper (July 29, 2013).

5.11 Social, Political and Ethical Issues

Social, political and ethical issues lead to diversity in their engagement with topics such as social justice. Christian denominations may hold a wide range of views on social, political and moral issues such as human sexuality, marriage, gender roles, bioethics, war, capital punishment, human rights, poverty, environmental stewardship, and the role of government. These differences can impact public

engagement, advocacy, and the witness of the Church in society W. E. Hopkins (1997), Sage (1997). Ethical dimensions of diversity stem from differing interpretations of scripture, tradition, and contemporary moral dilemmas. Wells, & B. Quash (2017).

5.12 Interpretations of Scripture

Different interpretations of the Bible can lead to divergent beliefs and practices among Christians. While all Christians regard the Bible as authoritative, disagreements over its interpretation can lead to varying understandings of key theological concepts and ethical teachings. Differences in theological texts and doctrinal statements have given rise to diverse belief systems within Christianity. Such disagreements over the meaning and application of scripture have led to a proliferation of Christian denominations and traditions, leading to variations in beliefs on theological issues, moral teachings, and social practices.

5.13 Nature of the Church

5.16 Historical Events and Developments

Historical events such as the Great Schism of 1054, the Protestant Reformation, and the subsequent Counter-Reformation have had lasting effects on the Christian church, contributing to the formation of distinct traditions and practices. Furthermore, Christianity has a rich and complex history spanning two millennia. Throughout this time, religion has encountered diverse cultures, languages, and philosophical traditions, leading to the development of various interpretations of Christian beliefs and practices. The historical development of Christianity, including its interactions with diverse cultures, intellectual traditions, and historical events, has led to various theological perspectives and doctrinal differences. 5.17 Liturgical Diversity
